Counseling and Guidance Mission Statement

The Morris Central School Counseling and Guidance Department will provide a comprehensive, developmental counseling program that targets the academic, career and social-emotional development of all students. Every student in our district is empowered to achieve their personal, academic, and career goals in a supportive and inclusive environment.

Program Evaluation

This plan is a working document that will require annual evaluation and assessment by the Advisory Council. The annual review process will be based on our progress toward meeting the standards established in Appendix A. Appendix B contains a school counseling program assessment tool that is completed with the Advisory Council during the fall and spring meetings.

Delivery of Counseling and Guidance Services

Our counseling and guidance activities are driven by standards developed by the American School Counseling Association (ASCA), the New York State Career Development and Occupational Studies (CDOS) standards (Appendix C), and the New York State Social Emotional Learning Benchmarks (Appendix D). Ultimately, our goal is to ensure that all students in grades PK-12 are receiving instruction that delivers and meets these standards.

2024-25 School Counseling and Guidance Program Goals

PK-6

1. In class SEL lessons address the development of self-awareness, strong sense of personal identity, decisions about personal actions, emotional/social intelligence, bullying, internet safety, and personal safety.
2. Individual and small group counseling to address obstacles to academic and social success.
3. Students visit the OAOC BOCES Occupational Center in Milford to explore career technical careers and academic options.
