The meeting was called to order by President Mary Dugan at 6:30 p.m.

The minutes of the regular meeting of February 16, 2023 were approved as presented on the motion of Emily Boss, seconded by Wendy Moore, and carried 5-0.

Sarah Bradshaw and Jason Schwartz from Bernard P. Donegan. Inc. talked to the Board about the Five-Year Financial Plan.

Teresa Kane talked to the Board about her math curriculum. She told the Board that college credits are available for algebra 2.

#### **Superintendent's Reports:**

Jamie Maistros talked to the Board about the two locations the architects are suggesting for the softball field. The soil boring samples taken came back good. Mrs. Maistros is attending the village meeting next week to discuss the soil sampling. Teresa DeLaurentiis would like to see the trees that are taken down, replaced.

Jamie Maistros talked to the Board about the 2023-2024 Budget. We are at a budget increase of 4.46% and a tax increase of 3.24%. We are looking at ways to reduce both the budget and tax increase. Mrs. Maistros discussed the increase in the cost of special education. We are looking into shared services because of the high cost through BOCES and taking tuition students from other districts.

Jamie Maistros talked to the Board about the transportation plan if there was an accident. We have been advised by the legal department that no one without a CDL should be transporting students. We had discussed coaches driving the team, but without a CDL license we were advised that this should not happen.

Jamie Maistros talked to the Board about the Village Library of Morris requesting an increase of \$7,215 in taxes this year. This brings the total up to \$65,000. The consensus of the Board was to put the increase on the ballot and let the voters decide.

Jamie Maistros talked to the Board about possible banking changes. Community Bank would like to be our bank of record. Our General Fund goes into NBT and then is moved to Community. There are interest bearing money market account that money can be put into that earns 4.2% interest instead of .02%. The Auditors advise that we should not have all the money in one bank. The consensus of the Board was to make Community Bank our bank of record but to leave the NBT account open.

Jamie Maistros talked to the Board about transitioning our website to a different provider. It should be more user friendly.

### Principal's Reports:

Brian Breck talked to the Board about school events. There was a Pops Concert on March 8, 2023. Students in grades four through twelve sang or played popular music. The concert was about an hour long.

Brian Breck talked to the Board about the student teachers we have at Morris. There are six student teachers. Four are in the elementary grades, one each in first, third, fourth and sixth grades. There is also a student teacher in Mr. Harmer's and Mrs. Grant's rooms.

Brian Breck talked to the Board about field trips. There was an Athletic Conference on March 3<sup>rd</sup>. The Athletic Club brought five juniors and a coach to Clarks Sports Center for a Student Athlete Leadership Conference. Students in grades eleven and twelve went to see Of Mice and Men at the Sidney Central School auditorium.

Brian Breck talked to the Board about the AI software. Julene Waffle assigned her students to write an original poem. She noticed something wrong with one of the poems. She ran the poem through a Google program looking for plagiarism, but it didn't find any. She was aware of a program that generated poems. She had a discussion with the class about it not being plagiarism but it was not an original. The student admitted using the program. We plan on doing some professional development about these programs with the teachers.

Brian Breck told the Board that during Spirit Week we had Teacher Swap (Students dressed like teachers and teachers dressed like students), Valentine's day, PJ Day, Hawaiian Day and Color Wars Day.

Brian Breck talked to the Board about some upcoming dates. 3/17 is Superintendent's Conference Day, 3/17 and 3/18 Spring Musical Play, 3/24 Corning Glass Field trip, 4/3-4/10 Spring Break.

- 1. Approval of Bryan Matson as a probationary cleaner retroactive to February 27, 2023. Mr. Matson's salary will be \$29,536, prorated February 27 through June 30, 2023.
- 2. Approval of Stephani Michalak as a substitute teacher aide for the remainder of the 2022-2023 school year.
- 3. Approval of an Extra Challenging Stipend for Lisa Marino retroactive to February 17, 2023. The stipend is \$1,235, prorated February 17 through June 23, 2023. If the position no longer calls for an Extra Challenging Stipend, it will be removed.
- 4. Approval of Maria Deysenroth as a GED Supervisor with a stipend of \$18.00 per hour.
- 5. Approval of Michael D'Amico as an unpaid assistant coach for track for the 2023 season.
- 6. Approval of Liana Garry as a substitute teacher (NC) for the remainder of the 2022-2023 school year.

# EXTRACT OF MINUTES OF MEETING OF THE BOARD OF EDUCATION OF THE MORRIS CENTRAL SCHOOL DISTRICT ADOPTING BOND RESOLUTION

At a regular meeting of the Board of Education of the Morris Central School District, New York, held at the District Offices in Morris, New York, on the 16<sup>th</sup> day of March, 2023:

Russell Tilley presented the following resolution and duly moved that it be adopted and was seconded by Emily Boss:

BOND RESOLUTION DATED MARCH 16, 2023 OF THE BOARD OF EDUCATION OF THE MORRIS CENTRAL SCHOOL DISTRICT AUTHORIZING GENERAL OBLIGATION BONDS TO FINANCE THE ACQUISITION OF A SCHOOL BUS, AUTHORIZING BOND ANTICIPATION NOTES IN CONTEMPLATION THEREOF, THE LEVY OF TAXES IN ANNUAL INSTALLMENTS IN PAYMENT THEREOF, THE EXPENDITURE OF SUCH SUMS FOR SUCH PURPOSE, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the qualified voters of the Morris Central School District, New York, at a special meeting of such voters duly held on March 8, 2023, duly approved a proposition authorizing the levy of taxes to be collected in installments, in the manner provided by the Education Law, for the specific object or purpose hereinafter described; now therefore

#### BE IT RESOLVED BY THIS BOARD OF EDUCATION AS FOLLOWS:

<u>Section 1</u>. The Morris Central School District has undertaken or shall undertake certain capital expenditures, as more particularly described in Section 3 hereof.

<u>Section 2</u>. The Morris Central School District is hereby authorized to issue its General Obligation Serial Bonds in the aggregate principal amount of not to exceed \$160,609, pursuant to the Local Finance Law of New York, in order to finance the specific object or purpose described herein.

- Section 3. The specific object or purpose to be financed pursuant to this resolution (hereinafter referred to as "purpose") is the acquisition of one (1) 65-passenger school bus, at an estimated maximum cost of \$160,609.
- Section 4. It is hereby determined and declared that (a) the maximum aggregate cost of said purpose, as estimated by the Board of Education, is \$160,609, and such amount is hereby appropriated therefor, (b) the Morris Central School District plans to finance the cost of said purpose entirely from funds raised by the issuance of said Bonds and the Bond Anticipation Notes hereinafter referred to, and (c) no money has heretofore been authorized to be applied to the payment of the cost of said purpose.
- <u>Section 5</u>. It is hereby determined that the purpose is one of the class of objects or purposes described in Subdivision 29 of Paragraph a of Section 11.00 of the Local Finance Law, and that the period of probable usefulness of said purpose is five (5) years.
- <u>Section 6</u>. The Morris Central School District is hereby authorized to issue its Bond Anticipation Notes in the aggregate principal amount of not to exceed \$160,609, and is hereby authorized to issue renewals thereof, pursuant to the Local Finance Law of New York in order to finance the purpose in anticipation of the issuance of the above described Bonds.
- <u>Section 7</u>. It is hereby determined and declared that (a) there are presently no outstanding Bond Anticipation Notes issued in anticipating of the sale of said Bonds, (b) the Bond Anticipation Notes authorized hereby are not issued in anticipation for Bonds for an assessable improvement.
- Section 8. It is hereby determined and declared that the Morris Central School District reasonably expects to reimburse the general fund, or such other fund utilized, not to exceed the maximum amount authorized herein, from the proceeds of the obligations authorized hereby for expenditures, if any, from such fund that may be made for the purpose prior to the date of issuance of such obligations. This is a declaration of official intent under Treasury Regulation §1.150-2.
- Section 9. The faith and credit of the Morris Central School District, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such Bonds and Bond Anticipation Notes as the same respectively become due and payable. And annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. There shall annually be levied on all taxable real property of said School District, a tax sufficient to pay the principal of and interest on such obligations as the same become due and payable.
- <u>Section 10</u>. The power to further authorize the issuance of said Bonds and Bond Anticipation Notes and to prescribe the terms, form and contents of said Bonds and Bond Anticipation Notes, subject to the provisions of this resolution and the Local Finance Law of New York, including without limitation, the consolidation with other

issues, the determination to issue Bonds with substantially level or declining annual debt service, whether to authorize the receipt of bids in an electronic format, and to sell and deliver said Bonds and Bond Anticipation Notes, is hereby delegated to the President of the Board of Education or to the Vice President of the Board in the event of the absence or unavailability of the President. The President of the Board of Education and the District Clerk are hereby authorized to sign by manual or facsimile signature any Bonds and Bond Anticipation Notes issued pursuant to this resolution, and are hereby authorized to affix to such Bonds and Bond Anticipation Notes the corporate seal of the School District and to attest the same.

Section 11. This resolution, or a summary hereof, shall be published in full by the District Clerk of the School District together with a notice in substantially the form prescribed by Section 81.00 of said Local Finance Law, and such publication shall be in each official newspaper of the School District. The validity of said Bonds and Bond Anticipation Notes may be contested only if such obligations are authorized for an object or purpose for which said School District is not authorized to expend money, or the provisions of law which should be complied with, and an action, suit or proceeding contesting such validity, is commenced within twenty (20) days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution.

Section 12. This resolution shall take effect immediately upon its adoption.
